



Bibliometric Analysis of Book Reviews Published in Contributions to Indian Sociology (1984-2015)

Abstract

This study aims to present a bibliometric analysis of the book reviews published in Contributions to Indian Sociology (CIS) for the period of 31 years from 1984 to 2015. The analysis cover mainly the authorship/editor pattern, ranking of authors/ editors/ reviewers, ranking of publishers, subject wise distribution, chronological distribution, price wise distributions etc. through the graphs and tables. This study points out towards the merits and weakness of the journal which will be helpful for its further development. The findings of the present study leads to the conclusion that this journal deserves popularity among researchers in the area of social sciences. In addition, it also reflects increased interaction with other subject disciplines

1 Introduction

Bibliometrics is an emerging thrust area of research in the field of Library and Information Science. A set of methods used to study or measure texts and information. Bibliometric studies have been applied mainly to scientific fields and are based principally on various metadata elements like author, title, subject, citations etc. related to scholarly publication within a discipline. It first appeared in 1969, and it became more popular during 1980s. The word 'Bibliometric' is derived from Latin and Greek words i.e., 'Biblio' and 'metric'. So etymologically it stands for the application of mathematics to the study of bibliography. Pritchard (1969) defined 'bibliometric' as 'the application of mathematics and statistical methods to books and other media of communication'. According to the British Standards Institution the study of the use of documents and patterns of publication in which mathematical and statistical methods have been applied'. Sengupta (1980) opines bibliometrics as organization classification and quantitative evaluation of publication patterns of all macro and micro communication along with their author ship by mathematical and statistical calculus.

2 Book review



According to World Book encyclopedia, Book Review is “An article published in a newspaper or periodicals that announces the publication of books and tells, “What is about and evaluate it”.

In different languages it is known as “literary criticism” in English, “Alochana and Sameeksha” in Hindi, “Teeka” in Sanskrit and “Tabsera and Tanqeed” in Urdu, and “Granth Prikshan” in Marathi. However the concept of Book Review started in 17th Century and by the 19th Century it firmly established. A book review is a form of literary criticism in which a book is analyzed based on content, style, and merit. It can be reviewed for primary source opinion piece, summary review or scholarly review. Book Reviews are published in newspapers and periodicals along with the news items and other articles. There are so many periodicals which solely focus on Book Review e.g. “Biblio, The Book Review, Feminist Europe, Review of Books, Women Artists News Book Review, and The Women’s Review of Books etc.” Newspapers like “Asian Age”, “Deccan Herald”, “Hindu”, “Indian Express”, and “Telegraph”, etc. usually publish the Book Reviews.

3 About Contributions to Indian Sociology (CIS)

CIS is a peer-reviewed journal which has encouraged and fostered cutting-edge scholarship on South Asian societies and cultures over the last 50 years. CIS was founded by Louis Dumont and David Pocock in 1957. The journal published annually till 1974, CIS became a biannual publication in 1975 from 1999 onwards the journal is published thrice a year. It is sponsored by the Institute of Economic Growth, Delhi and published by Sage, New Delhi. CWDS library possess this journal from the year 1984 onwards.

The content of the CIS includes research articles, short comments and book reviews. The journal also publishes special issues to highlight new and significant themes in the discipline. The CIS has been selected as the source journal of the present study. It is one of the leading journals in the field of social sciences. An attempt has been made to study the book reviews published in Contributions to Indian Sociology. Present article narrates various features and shortcomings of the book reviews published in the journal.

4 Need for the Study

The periodicals are the indicators of literature growth in any field of knowledge. They emerged as the main channel for transmitting current knowledge. Periodicals are considered as one of the primary source of information in any given discipline, and more so in newly emerging and expanding area like women’s studies. Bibliometric analysis has many applications in the Library and Information Science filed in identifying the research trends in the subject. The study will be helpful for librarians to plan a better collection development policy

5 Scope

Contributions to Indian Sociology are an important scholarly journal of Social Sciences. It covers many scholarly articles on women’s studies, and also covered book reviews of women’s studies books. This study covers the period of 31 years from 1984 to 2015. Total No. of issues are 82. 1383 Book reviews were published in these issues during the period of study. Over 279 book reviews have been published on women’s studies from 1984 to 2015.

6 Objectives



The purpose of this article is to conduct a comprehensive bibliometric assessment of Book Reviews published in Contributions to Indian Sociology (CIS) : Pattern of authors, editors and reviewers ranking of reviewers, publishers and authors distribution of books according to subject (women’s studies and other disciplines) language, , chronological book reviews, gaps between books published and reviewed, books reviewed by faculty members of Centre for Women’s Development Studies faculty member’s and their books reviewed by others.

7 Methodology

The data required for present article was collected by referring to all issues of Contributions to Indian Sociology. Created a database furnishing the bibliographical details of each reviewed books. Observed, evaluated and analyzed all the records on the basis of different aspects of the book reviews and prepared tables, graphs and pie- charts for making observations.

8 Data Analysis

8.1 Authorship Pattern

It is observed from Fig. 1 that there are substantial number of single authors and single editors whose books were reviewed. Single authors 853 (62%) and single editors are 216 (16%) out of the total no of (1383) reviewed books. It implies that the single author and editors have taken more place in the Journal (CIS). The pattern on multiple authorship shows two authors 75 (5%), three authors 23(2%), more than three authors 8(1%) and Corporate authors 5(0%). While comparing editors contributions, the trend shows two editors 153(11%), three editors 45(3%) more than three editors 4(0%) and 1(0%) translator with less number of book reviews. These figure shows that edited books in comparison to authored books have occupied small part of collection. (Fig.1)

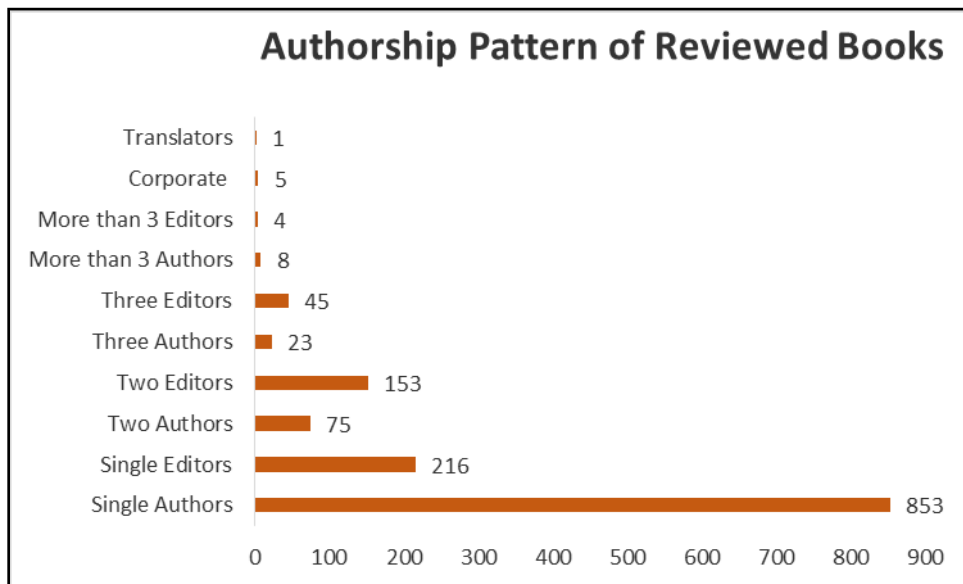

8.1.1 Authors (with more than one Books Reviewed):

Fig. 2 gives the information and rank of authors whose more than 1 book have been included in the review. Out of 1104 authors there are only 114 authors whose more than 1 books were reviewed. The authors are Ashis Nandy 7, T K Oommen 6 books and 4 authors 5 books, 5 authors 4 books, 20 authors 3 books, 83 authors 2 books and 990 authors 1 book were reviewed in the collection. (Fig. 2 and for Table see Annexure I)

Editors (with more than one books reviewed)

Fig. 3 reflects the information and rank of Editors whose more than 1 book was included in the review. Out of 561 Editors only 83 Editors are such whose more than 1 books were reviewed. The Editors are B S Baviskar and Veena Das 5 books 4 editors 4 books, 19 editors 3 books, 58 editors 2 books and 478 editors 1 book were reviewed in the collection. (Fig. 3 and for Table see Annexure II)

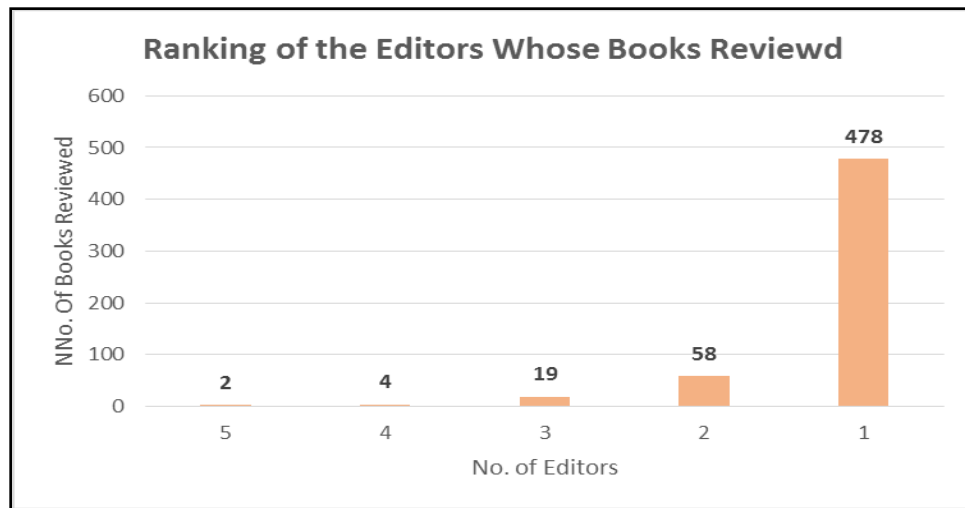

8.2 National and International Personalities whose Books were Reviewed

Fig. 4 provides the information about the National and International personalities whose books were reviewed i.e. 997 (56%) National and 774 (44%) International personalities. In spite of being an Indian Journal, international personalities were found to have a quite good position in the review. (Fig. 4)

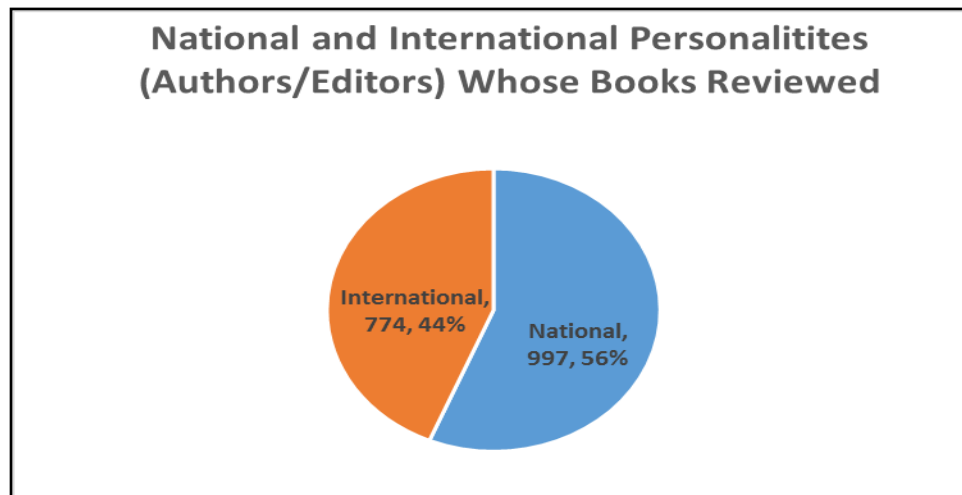

8.3 Ranking of Reviewers

It can be observed from the Annexure III during the period of 31 years, a total no. of 1383 books were reviewed by 637 reviewers. T N Madan reviewed 40 books, Patricia Uberoi reviewed 34 books, N Jayaram reviewed 24 books, Roma Chatterji reviewed 16 books, Satish Saberwal reviewed 14 books. 3 Reviewers reviewed 15 books, 3 Reviewers reviewed 13 books, 11 Reviewers reviewed 8 books, 4 Reviewers reviewed 7 books, another 11 Reviewers reviewed 6 books, 13 Reviewers reviewed 5



books, 32 Reviewers reviewed 4 books, 48 Reviewers reviewed 3 books, 94 Reviewers reviewed 2 books and 407 Reviewers reviewed just 1 book.

Table 1 shows the Rank of Reviewers. The objective of this table is to know the persons who reads recent books, study it and brings to the notice in the form of review for the use of the general users. It is also considered as a tool for publisher to give the publicity. (For reviewer data see annexure III)

8.4 Ranking of the Publishers of Reviewed Books:

Table 2 reveals that 338 books published by the Sage whether it is from India or Abroad included in the collection of CIS book reviews i.e. the largest number of books. 321 books published by Oxford University Press, 65 books published by Manohar, 36 books published by Motilal Banarsidass, 26 books published by Kali for Women were reviewed. Over 148 publishers whose one book was reviewed. Two books did not mention the place and publisher in the bibliographic detail.

8.5 National and International Publishers Whose Books were Reviewed

Fig. 5 provides the data about national and international publishers whose books were included in the review i.e. national publishers 1054 (76%) and international 327 (24%). Indian books have occupied large space of the total collection book reviews. (Fig. 5 and for Publisher data see Annexure IV)

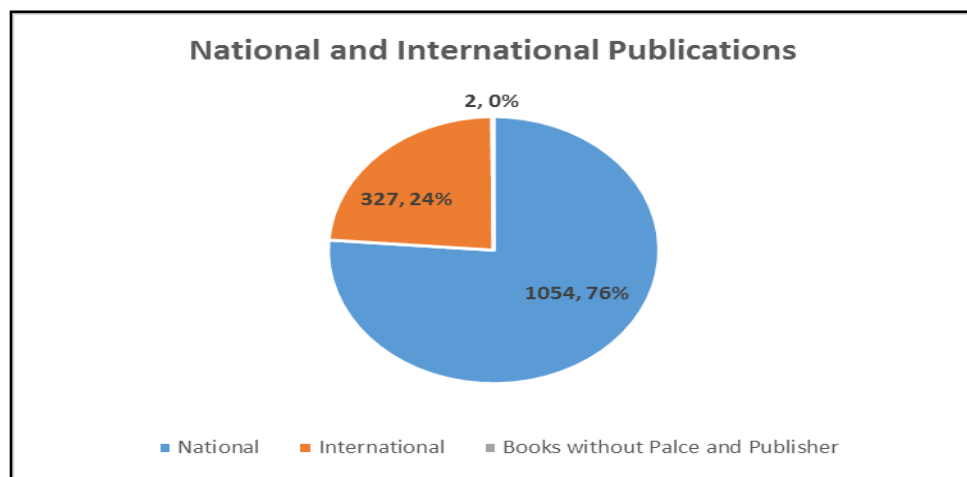

8.6 Distribution of Books According to Subjects

The CWDS library is subscribing the CIS since very long because it covers the good amount of articles of gender studies and social science disciplines. Fig. 6 gives the information related to subject wise distribution of books covered in the book reviews covering 38 Subjects. An analysis of data indicates that highest number of books focusing on Gender Studies was reviewed i.e 279. In the decreasing order 127 books on Religion, 85 on Social Structure, 83 books on history, and 81 on Sociology, 62 on Politics, 56 on Culture and 34 on Education etc. were reviewed. (Fig. 6)

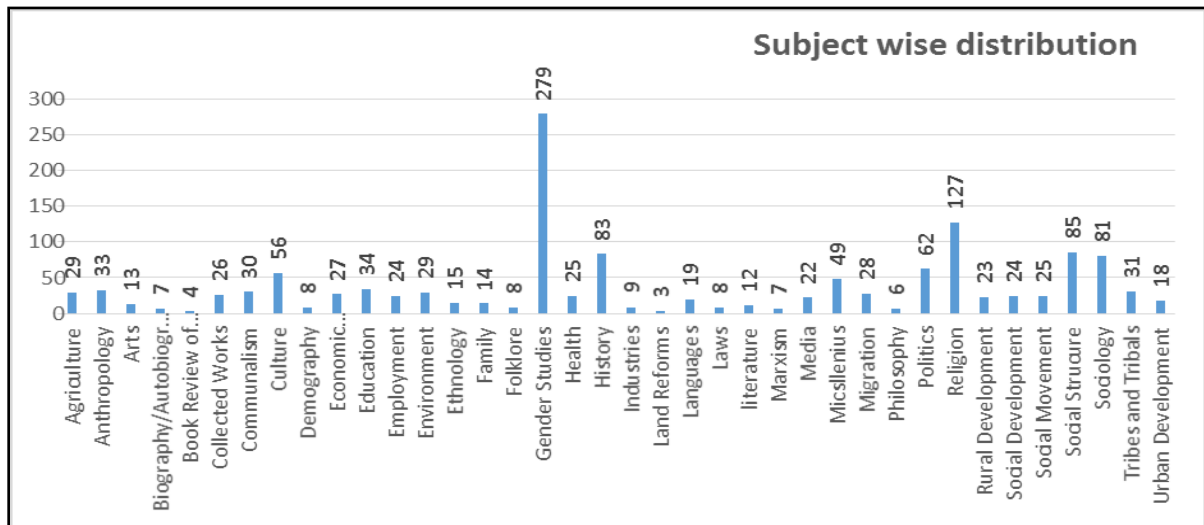

8.7 Language Wise Distribution:

It is observed from Fig. 7 that 1364 books of English language, 10 books of French and 1 book of German were reviewed. The CIS has also covered book reviews of the books which were published in Telugu 3; Sanskrit 2; Urdu 1 Hindi 1, Marathi 1, languages also. (Fig. 7)

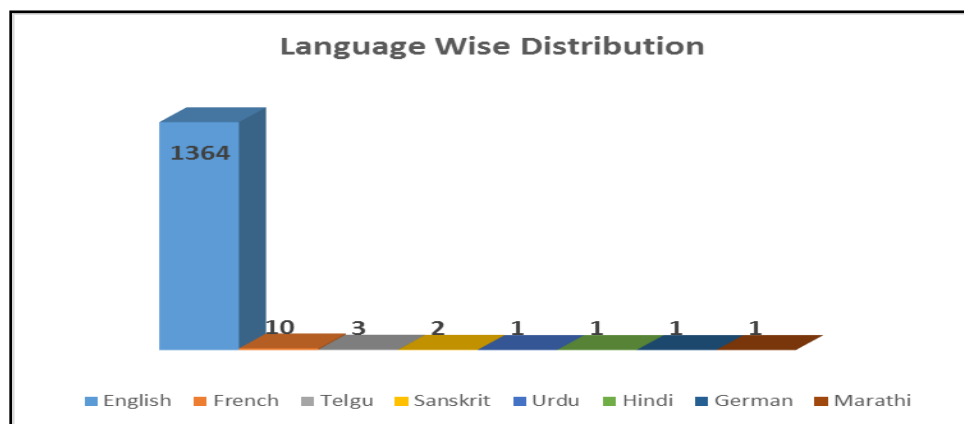

8.8 Price Wise Distribution of Books:

Fig. 8 shows that Indian books costing between the range of minimum Rs.10/- and maximum Rs.5096/- were reviewed. The prices of the foreign publications were in the total range of \$ 1-100; £ 1-more than 81; F.f. 1-300 and Tk. 200-230. 138 Books did not have the prices in bibliographic details of the book reviewed. 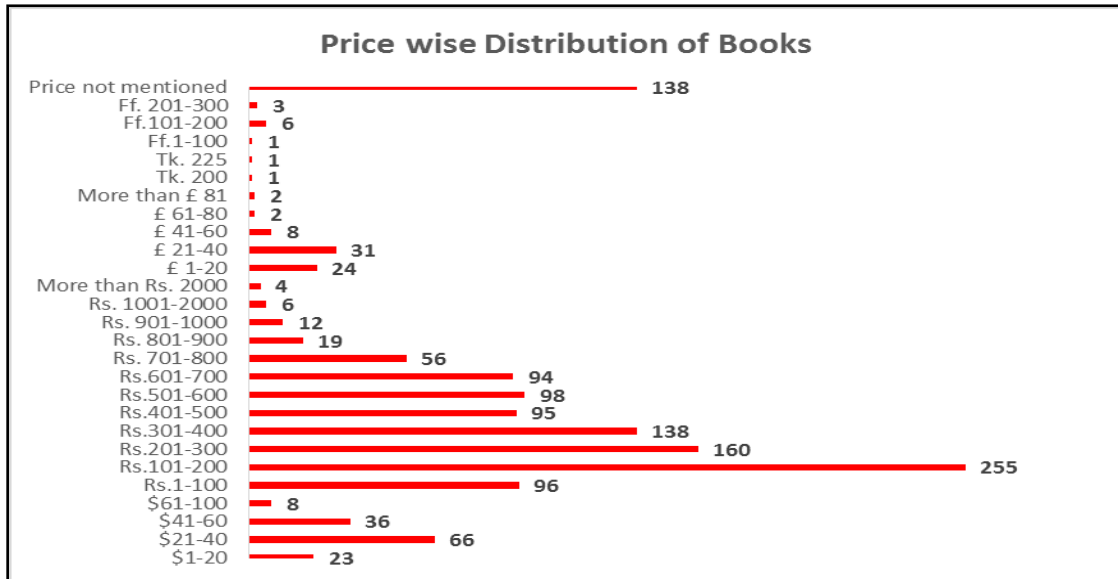

8.9 Book Reviews Published in chronological order

Fig. 9 analyzes the reviews in chronological order. It is observed that in the year 1989, 79 books reviews were published, which is the highest no. of the total book reviews. In the year 2000, 75 books reviews were published. From 2002 to 2015 the book reviews were decreased i.e. 20-40. In the year of 1995 no book reviews were published. (Fig. 9)

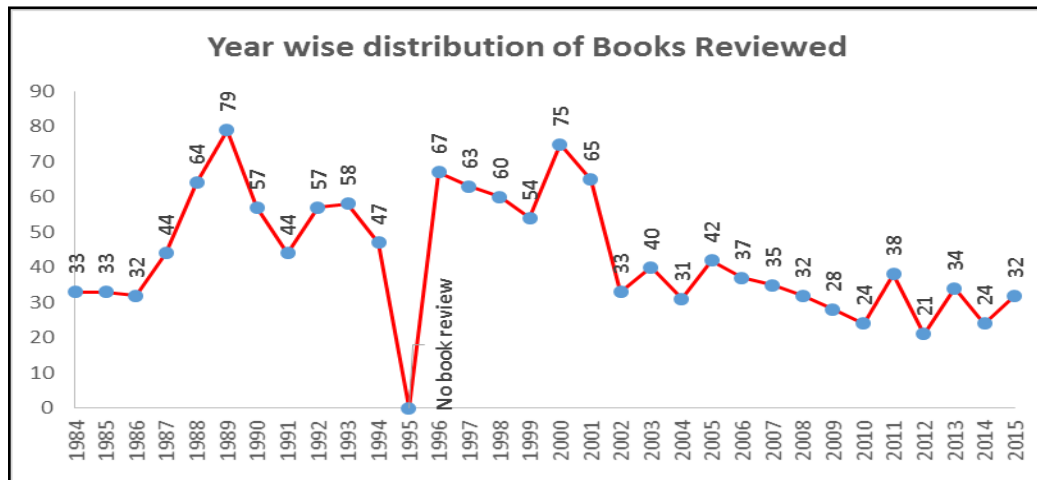

8.10 Gap between Year of Publication of Books and Review of Books

Fig. 10 shows that most of the books published within 2 years were reviewed, but in some cases, the gap between the publication of books and reviews range from 5 to 10 yrs. 22 publications were reviewed in the same year of publication. 384 books were reviewed within 1Year. of publication. 232 books were reviewed within 3 Years. of publication.115 books were reviewed within 4Years. of publication. This gap can be seen in Fig. 10 below

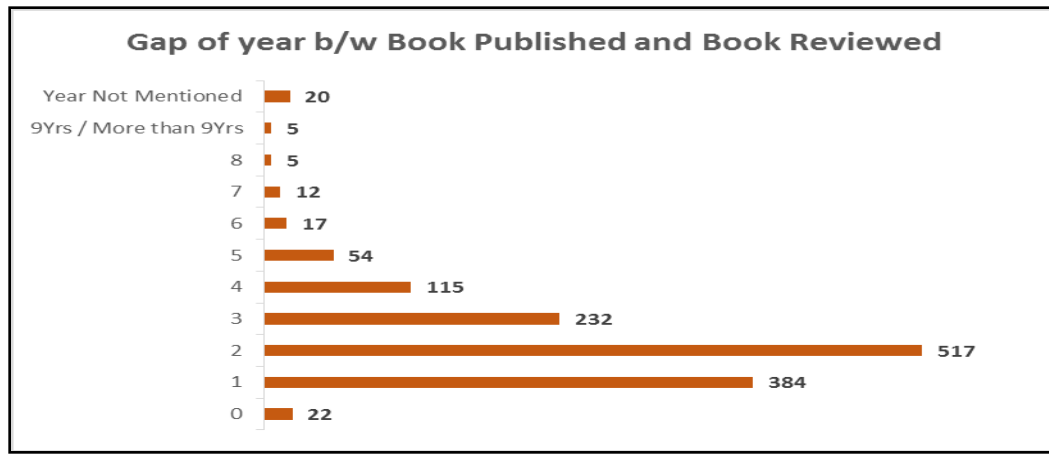

8.11 Books Reviewed by Faculty Members

Fig. 11 gives the information related to books reviewed by faculty members of Centre for Women’s Development Studies (CWDS). During the 31 Years (1984-2015), 10 CWDS faculty members reviewed 42 books of the total no. of books 1383. Dr. Renu Addalakha reviewed 13 books, which is the highest number of books reviewed by CWDS faculty. Anuja Agarwal reviewed 7 books, Anupama Roy reviewed 6 books, Uma Chakravarty reviewed 4 books, Dr. Mary E John and Smita Tiwari Jassal reviewed 3 books, Dr. Leela Kasturi reviewed 2 books, Dr. Sabiha Hussain and Dr. Vasanthi Raman Reviewed 1 book. 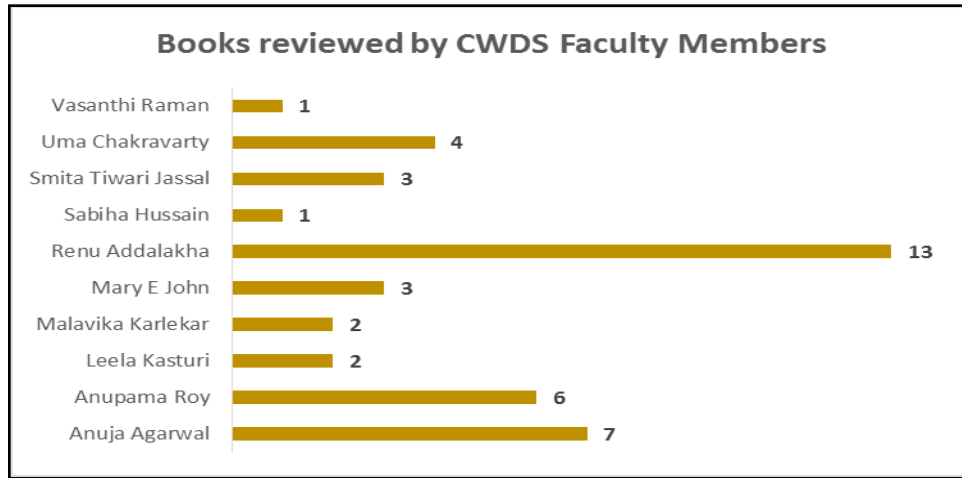

8.11.1 Faculty Member’s Books Reviewed

The CWDS Faculty had written 13 books during the period of 31 Years. Dr. Leela Dube wrote 4 books, Dr. Malavika Karlekar wrote 2 books, and Dr. Uma Chakravarti authored 2 books. Another 4 books written by other faculty members.

8.12 Affiliation of the Reviewers:

Fig. 12 presents the place of affiliation of Reviewers. 860 Reviewers (affiliated to Universities/Colleges/Departments which are the highest number. In the decreasing order 319 were affiliated to various Institutions like Institute of Economic Growth, Centre for Women's Development Studies etc. 161 Independent, 42 Government and 1(0%) to News Agencies. 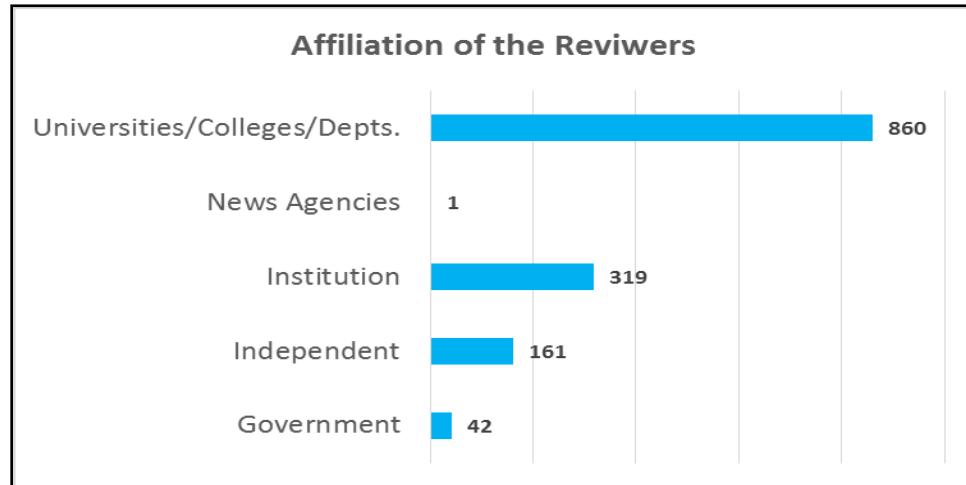

9 Findings and Conclusion

Contributions to Indian Sociology (CIS) is a core journal in the field of social sciences. Analysis of book reviews of 31 volumes of the journal shows that it covers contributions related to all aspects of social sciences such as Anthropology, Psychology, Philosophy, History and mainly on Gender Studies. The main findings of the analysis are as follows:

- Authorship pattern shows that most of the articles were contributed by single author with 853 (62%) and single editor with 216(16%, followed by decreasing order by two and more than two authors/editors.
- Most of the contributions are from India with 56% while foreign contributions are 44% of the total number.
- The study reveals that 407 reviewers reviewed only one book whereas one reviewer reviews as many as 40 books.
- It is observed that large number of books were published by Sage (338) from India as well as from abroad besides of other publishers. It is also observed that the contribution of Indian publishers 1054 (76%) is very high.
- The present study reveals that the highest number of book reviews have appeared in the area of Gender Studies with 279 of the total number of reviews.
- Review of 4 journals other than books, also appeared in the present study.
- It is observed that the maximum number of book reviews were published in the year 1989 (79 books) and gradually the number of books reviews decreased years after years, and there was no book reviews published in the year 1995.



- The Study shows that the highest contributions were from Universities/Colleges/Department with 860 of the total numbers.

The findings of the present study leads to the conclusion that this journal deserves popularity among researchers in the area of social sciences. In addition, it also reflects increased interaction with other subject disciplines.
